**WHEREAS**, after review by the Borough Manager, it was determined that the bid should be rejected because bidder:

- 1. Failed to submit a valid Public Works Contractor Registration Certificate
- 2. The bid guarantee was missing
- 3. The bidder stated an exception to the specifications on the bid sheet; and

**WHEREAS**, all of the foregoing defects constitutes fatal defects that cannot be cured,

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Borough of Fair Lawn, County of Bergen, State of New Jersey, that:

- 2. The bid received from Advantech Corporation, in response to SCADA System Maintenance and Improvements, is hereby rejected; and
- 3. The Borough Clerk is hereby authorized and directed to publicly advertise and solicit new bids for the Project; and
- 4. A copy of this Resolution shall be provided to the bidder who submitted a proposal for the Project.
