Mayor Robert A. Smith delivered the following address:

Gentlemen of the Council:

It now becomes our duty to launch the new ship of State, The Borough of Fair Lawn" upon its voyage into the great unknown future, with yourselves as the crew and I as your Captain and I sincerely pray, That with the help of God, that we may guide our craft through the many shoals and channels of civil life in safety, so that when we return to our port, our fellow men and women will say "Well done thou good and faithful servant."

I need not remind you at this time, that the eyes of our townsfolks, are, and will be, for sometime to come upon us, to see how we care for and nourish the infant municipality that has been placed in our custody; for I am sure that you are well aware of that fact.

However, I do want to impress upon you the necessity of sound sense, careful and practical deliberation upon your future ministering to its needs and requirements in order that it may develop and grow to a healthy and prosperous town second to none in the County of Bergen and be worthy of its Title "the Garden Spot of New Jersey".

To you the administration of Public affairs is something that you have never before been engaged in, but you have been placed here by our townspeople because you bear reputations of honesty ability and fair dealing in your various vocations and you are expected to apply those qualities in the administration of the business affairs of our Borough with the same reasoning and juris-prudence as you do to your own business.

Your path is not going to be one of roses. You are going to meet with obstacles, which at times are going to be very hard to over-come: in-fact many of them will sorely try your patience. You will meet with rebuffs, criticism, and very often abuse that will test every fiber and caliber of your manhood to the extreme of endurance, and the manner in which you meet these barriers and over come them shall determine your future right to leadership among your constituents.

You will be approached from all sides; both, within and without the Council Chambers, by individuals and small coteries, for special favors and request that will be represented to you as being the desires of the Public at large and I wish to take this opportunity of advising you against the making of any pledges for the support of theses projects, until you have first assured yourselves and determined that there is a public and popular demand on the part of the general public for the same: in other words ?"Be sure You're right, and then go ahead".

It becomes your duty to legislate wisely for the benefit of the people within there territorial limit of the Borough. All ordinances, Street maintenance, Repairs, Lighting, Expenditures, Improvements, taxation, and the supervision of the routine business of the Borough shall come within your jurisdiction.

It becomes my duty to consult and advise you upon these matters, to peruse and scrutinize the wisdom of your actions and proceedings upon all matters pertaining to the Public and I sincerely hope that we shall co-operate with each other for the mutual benefit of all.

Remember, Gentlemen of the Council, that we have been elected to our respective office, upon a platform of economy with which you are all familiar and I herewith charge you with a specific performance of your duties in accordance therewith.

In closing Gentlemen, let me suggest, that we all put our shoulders to the wheel, with the forward "ONWARD" for a greater, bigger and more prosperous BOROUCH OF FAIR LAWN.
