****Note: The sticker must be applied to the driver's side window of the vehicle. It is illegal to place it on the front windshield of any vehicle. The sticker must be affixed to the car registered above. Any sticker found illegally on a vehicle will be confiscated and the registered owner of the vehicle will be issued a summons.***

Resident Sticker Rules and Regulations

1. The vehicle which is issued the sticker must be registered to a Fair Lawn resident.
2. A sticker will only be issued after completion of the application and the Recycling staff being shown an official, valid registration for the vehicle being registered.
3. Only one sticker will be issued for each vehicle.
4. Stickers must be affixed to the driver's side window of the registered vehicle.
5. Stickers are **non-transferable** to any other vehicle.
6. Upon sale or disposal of the vehicle the sticker must be turned in to the Recycling office or a letter stating the sticker number must be sent stating that the vehicle no longer belongs to the registered owner.
7. Commercial or leased vehicles are not eligible for stickers.
8. The sticker does not grant any special rights or privileges to the registered vehicle or owner. All rules and regulations of the Recycling Drop Off Center must be followed as all violators are prosecuted.
9. The Recycling Department does not take the following materials under any circumstances:
 - Construction material
 - Hazardous materials including motor oil, antifreeze, paints, etc.
 - Furniture
 - Rugs, carpets or padding.
 - Styrofoam or unacceptable plastic
 - Car batteries
 - Rocks, dirt, soil, stones, woodchips, mulch, etc.
10. The Recycling Drop Off Center is open Monday through Friday from 8 AM to 4 PM, Saturdays from 9 AM to 1 PM and Sundays from Noon until 4 PM. The yard is closed at all other times and Borough holidays and anyone entering the yard is considered to be trespassing and will be prosecuted.
