## ORDINANCE NO. 2645-2023

**AN ORDINANCE TO AMEND CHAPTER 160, PARKS AND RECREATION AREAS, MORE SPECIFICALLY SECTION 160-12, “ACTIVITIES AND CONDUCT PROHIBITED IN BEACH AREAS AND IN PARKS” OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF FAIR LAWN, 2000**

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Fair Lawn as follows:

**SECTION 1.** Chapter 160, Parks and Recreation Areas, Section 160-12, Activities and Conduct Prohibited in Beach Areas and in Parks is hereby amended and supplemented by inserting the text **underlined and marked in bold** and deleting the text **[in brackets and marked in bold]** as follows:

§160-12      Activities and Conduct Prohibited in Beach Areas, **[and in] Parks and on Public Courts**

**E.      Private lessons on any public tennis, pickle ball, basketball or hockey court for money or other valuable compensation is prohibited, except for instruction sponsored or approved by the Superintendent of Recreation or designee.**

**SECTION 2:** If any section, paragraph, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to this section, paragraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**SECTION 3.** All ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 4.** This Ordinance shall take effect upon passage and publication according to law.
