ORDINANCE NO. 2653-2023

AN ORDINANCE FIXING THE SALARIES OF CERTAIN EMPLOYEES OF THE BOROUGH OF FAIR LAWN, BERGEN COUNTY, NEW JERSEY AS AMENDED-BLUE AND WHITE

WHEREAS, a need has arisen to amend Ordinance 2622-2022, adopted on 05/24/2022.

NOW, THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Fair Lawn, as follows;

SECTION 1. Ordinance 2622-2022 is hereby amended and ratified the position of Assistant Municipal Recycling Coordinator to the Borough of Fair Lawn's Blue and White Collar Bargaining Unit, effective 01/01/2023, shall be as follows:

SECTION 2. That all salaries not covered by this Ordinance will remain effective until amended by further salary ordinances.

SECTION 3. Salary increases are effective only if an employee has not resigned voluntarily or has not been terminated with cause. Retired employees are not eligible.

SECTION 4. All ordinances inconsistent with the provisions of the Ordinance are hereby repealed to the extent of such conflict or inconsistency. In the event of any inconsistencies between the provisions of this Ordinance and any prior Borough ordinances, the provisions hereof shall be determined to govern. All other parts and provisions of the Borough's ordinances are hereby ratified and confirmed, except where inconsistent with the terms hereof.

SECTION 5. This Ordinance shall take effect upon passage and publication as required by law.
