## ORDINANCE NO. 2654-2023

### AN ORDINANCE FIXING THE SALARIES OF CERTAIN EMPLOYEES OF THE BOROUGH OF FAIR LAWN, BERGEN COUNTY, NEW JERSEY AS AMENDED-STIPENDS

**WHEREAS**, a need has arisen to amend Ordinance 2614-2022, adopted on 04/26/2022.

**NOW, THEREFORE, BE IT ORDAINED**, by the Borough Council of the Borough of Fair Lawn, as follows;

**SECTION 1.** Ordinance 2614-2022 is hereby amended and ratifies the positions of Deputy OEM Coordinator, Deputy OEM Coordinator (ERRCS), Judge of Municipal Court, Prosecutor, Purchasing Administrative Assistant, Public Defender, and effective 01/01/2023, shall be as follows:

**SECTION 2.** That all salaries not covered by this Ordinance will remain effective until amended by further salary ordinances.

**SECTION 3.** Salary increases are effective only if an employee has not resigned voluntarily or has not been terminated with cause. Retired employees are not eligible.

**SECTION 4.** All ordinances inconsistent with the provisions of the Ordinance are hereby repealed to the extent of such conflict or inconsistency. In the event of any inconsistencies between the provisions of this Ordinance and any prior Borough ordinances, the provisions hereof shall be determined to govern. All other parts and provisions of the Borough's ordinances are hereby ratified and confirmed, except where inconsistent with the terms hereof.

**SECTION 5.** This Ordinance shall take effect upon passage and publication as required by law.
