ORDINANCE NO. 2656-2023

AN ORDINANCE TO AMEND CHAPTER 25, VOLUNTEER EMERGENCY SERVICES STIPEND PROGRAM OF THE CODE OF THE BOROUGH OF FAIR LAWN 2000

NOW THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Fair Lawn as follows:

SECTION 1. Chapter 25, Volunteer Emergency Services Stipend Program amended and supplemented by inserting the text **underlined and marked in bold** and deleting the text shown in **~~bold strikethrough~~** as follows:

Chapter 25. Volunteer Emergency Services Stipend Program

§ 25-4. Criteria for Payment of Quarterly Stipend

- a. [NO CHANGE]
- b. Criteria for payment of the quarterly stipend to active volunteer members shall be in accordance with the following schedules:
 1. Fair Lawn Volunteer Fire Department: **Schedule A**
 2. Fair Lawn Volunteer Rescue Squad: **Schedule B**
 3. Fair Lawn Volunteer Ambulance Corps: **Schedule C**

§ 25-6. Stipend Coordinator(s).

A. The Borough Manager shall appoint a Stipend Coordinator from each organization. The Stipend Coordinators of the Volunteer Rescue Squad and Volunteer Ambulance Corps shall be compensated at ~~\$1,750~~ **\$2,000** per year. The Stipend Coordinator of the Volunteer Fire Department shall be compensated at ~~\$2,500~~ **\$3,000** per year.

§ 25-7. Stipend Administrator.

A. The Borough Manager shall appoint a Stipend Administrator. The Stipend Administrator shall be compensated at ~~\$4,500~~ **\$5,500** per year.

SECTION 2: If any section, paragraph, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to this section, paragraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

SECTION 3. All ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. This Ordinance shall take effect upon passage and publication according to law.
