ORDINANCE NO. 2663-2023

AN ORDINANCE FIXING THE SALARIES OF CERTAIN EMPLOYEES OF THE BOROUGH OF FAIR LAWN, BERGEN COUNTY, NEW JERSEY - SOA

BE IT ORDAINED, by the Mayor and Council of the Borough of Fair Lawn, in the County of Bergen, State of New Jersey, as follows:

SECTION 1. Effective January 1, 2023 through December 31, 2026, the annual salaries and compensation of the Superior Officers of the Fair Lawn Police Department shall be paid in accordance with the Agreement between the Borough of Fair Lawn and the Fair Lawn Superior Officers Association Local No. 67 as follows:

SECTION 2. All salaries not covered by this Ordinance will remain effective until amended by further salary ordinances.

SECTION 3. Salary increases are effective only if an employee has not resigned voluntarily or has not been terminated with cause. Retired employees are not eligible.

SECTION 4. All ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency. In the event of any

inconsistencies between the provisions of this Ordinance and any prior Borough ordinances, the provisions hereof shall be determined to govern. All other parts and provisions of the Borough's ordinances are hereby ratified and confirmed, except where inconsistent with the terms hereof.

SECTION 5. This Ordinance shall take effect upon passage and publication as required by law.
